### Product: Solaron™ Blue APG

#### Description: Water conditioning dye.

Solaron™ Blue APG is a non-toxic, non-hazardous water conditioning dye recommended for pond, lakes, and fountains; which reduces sunlight penetration and colors the water a pleasant blue shade.

#### **Applications:**

Solaron™ Blue APG comes in water soluble packets which are conveniently packaged in re-closable foil bags or plastic buckets. Non-toxic and non-hazardous water soluble packets allow you to disperse the dye evenly by simply tossing a packet in to the water. Packets dissolve instantly after coming in contact with water. The color will last for up to 2-3 months.

Benefits to the product, “Solaron Blue APG”:

- 1.) High Quality – Our product has been rigorously tested by professionals in the pond and lake care industry to ensure the quality is the best in the market.
- 2.) Will Not Fade – Once the dye is applied properly it will last anywhere between 2 - 3 months.

- 4.) Works Instantly –As soon as you toss the packet the dye begins to disperse evenly in the pond/lake. Total dispersion may take 12-24 hours.
- 5.) Algae Control-The reduction of sunlight penetration diminishes the growth of algae in your pond or lake.

### **Directions for Usage:**

- 1.) Do not wear good clothing. Product will stain clothing like paint.
- 2.) We suggest that you apply only (1) packet per day until the desired shade is reached.
- 3.) Apply in the recommended ratios below.
- 4.) Allow 12-24 hours for dye to disperse throughout pond.

### **Storage:**

Do not let the product freeze. Store in a cool dry place.

### **Disposal:**

Triple rinse empty plastic container and recycle.
